#### Recommendation

### **Background**

The Highway Traffic Act (HTA) provides the council of a municipality the authority to designate a part of a highway under its jurisdiction as a Community Safety Zone (CSZ) if, in the council's opinion, public safety is of special concern on that part of the highway (1998, c. 6, s. 1.). Additionally, the Ontario Traffic Manual indicates that a CSZ may be used for roadways near schools, day care centres, playgrounds, parks, hospitals, senior citizen residences, or collision-prone areas.

As per the HTA, the official designation of a segment of roadway as a CSZ requires the enactment of a municipal by-law which includes the designated area and the erection of regulatory signs on the designated part of the roadway. Once a CSZ is designated and established, the HTA provides that any person convicted of specific offences described in the HTA is liable to increased fines if it is committed while in a CSZ.

City staff have received a request from the Laurentian Learning Centre on McKay Avenue to designate the area around their school as a community safety zone.

Public safety in the above noted area is of special concern due to the high volume of vulnerable road users including pedestrian traffic. The designation of a CSZ would raise driver awareness of public safety at this location near the

learning centre.

The current speed limit in this area is 50km/hr. A Community Safety Zone with a posted speed of 40km/hr is recommended for this area.

#### Recommendation

### **Background**

The Roads department relies on a large motor grader for snow and ice removal during the winter control season and throughout the rest of the year the grader serves as an indispensable piece of equipment for grading unpaved roadways and surface preparation. The current grader has experienced significant usage and has been identified as requiring replacement to prevent increasing downtime and questionable reliability due to its lifecycle, age, operation hours and mechanical condition.

The purchase of a new motor grader is necessary to replace the City's only unit which is no longer cost-effective to maintain as it approaches the end of its useful life. The operation and uptime of this specialized equipment is critical for providing essential services that cannot be carried out by any other piece of equipment in the fleet. Rental graders are very costly and not always available on demand. As downtime greatly affects the department operations a new motor grader will provide the City with efficient and dependable service for many years.

At a Special Council Meeting on December 20,2023 Council passed Resolution 2023-468(a) and (b) as follows:

Direct staff to develop and issue a Progressive Design Build Request for Proposals to be issued early in the first quarter (Q1) of 2024 for substantial construction completion of the Project in 2025 and meets the CaGBC Design Standard v2 requirements of the GICB funding contribution agreement; and

Direct staff to prepare budget target options for Council consideration early in

2024 to establish the budget target that will be part of the RFP to be issued to

market in early Q1 2024 that ensures broad industry interest and participation.

(b) as per the original barrier free design to be issued V2 and/or V3 requirements."

The North Bay Community and Recreation Centre project ("Project") is a Greenfield arena project that will be located adjacent to, and integrated into, the existing Omischl Sports Field Complex opened in 2011, at 1099 Lakeshore Drive in North Bay, Ontario. The City intends to enter into a Progressive Design Build contract using a Canadian Construction Documents Contract (CCDC-14 2013) with Supplementary Conditions. The value of work required has a target project budget of \$59,500,000.00 (excluding HST). The City intends to use a Progressive Design-Build approach where Project Development Services are engaged to work towards an Owner's Statement of Requirements (OSR) and associated Guaranteed Maximum Price (GMP) or stipulated Contract Price. If the OSR and GMP or Contract Price are accepted by the City, a Change Order will be executed for commencement of final design and construction work.

The Project will include the minimal functional programming as attached as Appendix A to Report to Council CAO 2023-001 dated September 8, 2023 from John Severino. The Project will be designed to meet the Canadian Green Building Council (CaGBC) Zero Carbon Building (ZCB) – Design Standard (version 2 or 3) as required by the Green and Inclusive Community Building Fund's Contribution Agreement.

#### Recommendation

#### **Background**

A Class 'C' Environmental Assessment (EA) was originally completed in 1999 to determine and confirm the required McKeown Avenue improvements between Algonquin Avenue and Gormanville Road to meet the needs of the expected increase in traffic demands as a result of the increase in development in the surrounding area. Improvements to McKeown Avenue between Highway 11/17 and Champlain Street were implemented in 2009 and this project includes the improvements to McKeown Avenue from Cartier Street to Gormanville Road. Given the time lapse of the original EA that occurred, an EA amendment was completed confirming that McKeown Avenue is to be widened to four lanes of traffic with two lanes in each direction.

In addition to the widening of McKeown Avenue is the implementation of active transportation facilities which were discussed at length with the City's Active Transportation Committee which resulted in implementing a new multiuse path (MUP) in the boulevard on the south side of the road and replacing the new concrete sidewalk on the north side. The MUP will extend from Gormanville Road to the intersection at A&W with future plans for the MUP to

extend and connect to the existing MUP on Airport Road. The McNamara intersection will be constructed with new traffic lights providing a new controlled crossing for both pedestrians and cyclists.

All existing underground water and sewer services are also being replaced other than the large concrete trunk storm sewer which will only receive minor localized repairs. A new storm sewer will be installed beneath the multi-use path as part of the stormwater management design to collect and store the stormwater runoff for the added hard/impervious surfaces (e.g. traffic lanes, MUP, etc.) before outletting into the ditch crossing Highway 17.

Other improvements include the replacement and addition of new streetlights including new pedestrian lighting for the sidewalk on the north side of the road.

The road reconstruction and widening of McKeown Avenue was approved for funding through the Investing in Canada Infrastructure Program (ICIP): Rural and Northern Stream. Under the program, approximately 83.33% of eligible costs will be funded by the provincial and federal governments up to a combined maximum contribution of \$4,166,500.

#### Recommendation

That City Council approves the award of a contract to EXP Services Inc. in the amount of \$1,109,522.50 (plus HST) for the provision of professional engineering services for the sidewalk program; and that City Council authorizes the transfer of funds to the project as outlined in Report to Council No. CORP 2024-036.

#### **Background**

The contract will provide professional engineering services for the design and construction assistance of sidewalks on one side of the road in locations throughout the City that currently have transit routes. To facilitate the installation of the sidewalks the program will include the installation of storm sewers, curb & gutter, restoration, and partial asphalt paving including granular road base.

This program is a multi-year construction project that will benefit the neighborhoods that don't have existing sidewalks available to provide safe and reliable travel for pedestrians to and from existing transit stops.

The preliminary and detailed design for all sections will be completed from 2024 to 2026 to ensure tender ready contracts are issued during the winter period prior to each construction season. Construction of the various sections of sidewalks is expected to commence in 2024 with the final section completed in 2031.

#### Financial/Legal Implications

A formal bid request, which closed April 2, 2024, was administered by the Purchasing Department and was publicly advertised in accordance with the City's Purchasing By-Law 2013-200. Three (3) proposals were evaluated by the Interim Purchasing Manager, the Senior Project Manager, Municipal Engineer and the Senior Municipal Engineer. The evaluation considered experience and qualifications, statement of understanding and methodology, work plan, project schedule, risk management and price.

The results are as follows:

The proposal from EXP Services Inc. scored highest and provides the best overall value to the city. Their bid is considered fair and reasonable.

Funding for the design and current year engineering services is available in Project No. 4330TR – Construction of Sidewalks for Transit Routes. To assist with project management, an amount of \$1,759,859 will need to be transferred from Capital Project No. 4303RD – Premier Sidewalk and Resurfacing to 4330TR - Construction of Sidewalks for Transit Routes to cover the total project costs including the design, engineering, construction contract and contract administration services.

The project has been identified in the City's 10 Year Capital budget. Future year capital budgets will continue to include sufficient funding to support the completion of the project.

By-Law No. 2024-40

### Being a By-Law to Amend By-Law No. 2012-97 (Being a By-Law to Regulate Smoking in Public Places and Workplaces)

Whereas Section 115 of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, authorizes the Council of a local municipality to pass a by-law to prohibit or regulate the smoking of tobacco in public places and workplaces within the Municipality;

And Whereas section 10(2) of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, authorizes a municipality to pass by-laws respecting health, safety, and well-being of persons;

And Whereas section 18 of the *Smoke-Free Ontario Act*, 2017, S.O. 2017, c. 26, Sched. 3, as amended, permits municipalities to enact smoking by-laws that are more restrictive than found in the Act, subject to sections 19 of the Act;

And Whereas Council passed Resolution No. 2024-\_\_\_\_\_ at its Regular Meeting held Tuesday, May 7<sup>th</sup>, 2024, to authorize smoking prohibitions for requested workplaces and apartment buildings,

Now therefore be it resolved that the Council of the Corporation of the City of North Bay enact as follows:

- 1. That Schedule "A" be deleted, and the attached Schedule "A" be inserted in lieu thereof.
- 2. This amending by-law shall come into force and effect on May 7, 2024.

### By-Law No. 2024-39 Being a By-Law to Confirm Proceedings of the Regular Meeting of Council Held on May 7<sup>th</sup>, 2024

**Whereas** the *Municipal Act, R.S.O. 2001*, Chapter 25, (the "Act") Section 5(1), provides that the powers of a municipal corporation shall be exercised by Council;

**And Whereas** Section 5 (3) of the Act provides a municipal power, including a municipality's capacity, rights, powers and privileges under section 9 of the Act, shall be exercised by by-law unless the municipality is specifically authorized to do otherwise and any of the matters shall be implemented by the exercise of the natural person powers;

**And Whereas** in many cases action which is taken or authorized to be taken by Council does not lend itself to the passage of an individual by-law;

### Now Therefore, The Council of The Corporation of The City of North Bay Hereby Enacts As Follows:

- 1. That the actions of the Council of The Corporation of the City of North Bay at its Regular Meeting held on May 7<sup>th</sup>, 2024 in respect of each motion, resolution and other action passed and taken by the Council at is said Meeting is, except where the prior approval of the Local Planning Appeal Tribunal or other authority is by law required, hereby adopted, ratified and confirmed.
- 2. That where no individual by-law has been passed with respect to the taking of any action authorized in or by the Council mentioned in Section 1 hereof or with respect to the exercise of any powers of the Council, then this by-law shall be deemed for all purposes to the by-law required for approving and authorizing the taking of any action authorized therein or thereby required for the exercise of any powers therein by Council.
- 3. That the Mayor and the proper officers of The Corporation of the City of North Bay are hereby authorized and directed to do all things necessary to give effect to the said actions or to obtain approvals where required, and to execute all documents as may be necessary and directed to affix the corporate seal to all such documents as required.
