Subject: Request for Proposal 2020-31 Design Services for Downtown Main Street Reconstruction

Recommendation

That City Council approves the award of a contract to R.V. Anderson Associates Limited for an amount up to \$340,607.00 (plus HST) for the provision of design services related to the Downtown Main Street Reconstruction; that Council authorizes the transfer of funds to the project as outlined in Report to Council No. CORP 2021-02; and that City Council authorizes the pre-commitment to the 2021 Capital budget as outlined in Report to Council No. CORP 2021-02.

Background

The City requires the services of a qualified engineering consultant to complete the preliminary and detailed design of the Downtown Main Street Reconstruction (Main Street from Cassells Street to Sherbrooke Street and Ferguson Street from Main Street to Oak Street). Much of the surface infrastructure in North Bay's downtown has reached the end of its life and requires replacement, including interlocking brick roadway and sidewalks, curbs and gutters, retaining walls, stairs, railings, benches, and lighting. The last major renovations were completed nearly 40 years ago and deterioration of the hardscapes is now prevalent.

In 2016, the North Bay Downtown Waterfront Master Plan Study (DWMP) was commissioned by the City of North Bay and carried out over a 10-month process. The DWMP was adopted by Council in the fall of 2019. A key component of the DWMP is the revitalization of Main Street which will include the replacement of the surface infrastructure in line with the concepts and renderings in the DWMP. These concept designs will be used as the basis for the engineering and landscaping designs, which will also evaluate and consider different material types for the various components. Streetscaping improvements will help to improve the attractiveness and overall usability of this historical Main Street.

Financial/Legal Implications

A formal bid request, which closed December 3, 2020, was administered by the Purchasing Department and was publically advertised in accordance with the City's Purchasing By-Law 2013-200. Five proposals were evaluated by the Purchasing Manager, the Special Project Development Planner, the Manager, Planning & Building Services and the Senior Capital Program Engineer. The evaluation considered experience, qualification, response to the scope of work and price.

The results are as follows:

The proposal from R.V. Anderson Associates Limited scored highest and provides the best overall value to the City. Their bid is considered fair and reasonable.

Funding for this contract is available in Capital Project No. 3934RD/ST - Main St. Paving Stone Replacement, which has a combined budget of \$200,000. The contract includes the provision of design services and construction inspection. It is estimated that a total of \$436,096 is required to cover the costs of the contract as well as other costs required to complete the design for the Main St. Paving Stone Replacement and provide for a small contingency for the project. Accordingly, a total of \$236,096 will need to be transferred to Capital Project No. 3934RD - Main St. Paving Stone Replacement from other projects as follows:

- \$43,209 from Project No. 3920RD - O'Brien Street - Ski Club to Airport & Ski Club Signals
- \$19,324 from Project No. 3920ST - O'Brien Street - Ski Club to Airport & Ski Club Signal
- \$27,486 from Project No. 3931RD - Ellendale Second Feed
- \$23,195 from Project No. 3952RD - Pinewood Park Drive Cooks Creek Culvert

Replacement

- \$53,000 from Project No. 4033RD - Roadside Guardrails and Retaining Walls - Inspection and Upgrade. This funding has been budgeted through the 2021 Capital Budget; therefore, approval of the transfer will represent a commitment against the 2021 Capital Budget
 - \$50,057 from Project No. 6520RD - Design Work Next Year's Projects 2020 On-going
 - \$19,825 from Project No. 6520ST - Design Work Next Year's Projects 2020 On-going (Project 6520ST to be closed following the transfer of funds)

Options Analysis

1. That City Council approves the award of a contract to R.V. Anderson Associates Limited for an amount up to \$340,607.00 (plus HST) for the provision of design services related to the Downtown Main Street Reconstruction; that Council authorizes the transfer of funds to the project as outlined in Report to Council No. CORP 2021-02; and that City Council authorizes the pre-commitment to the 2021 Capital budget as outlined in Report to Council No. CORP 2021-02.
 2. Do not award a contract. This option is not recommended because the surface infrastructure on Main Street downtown is at the end of its life and is beyond rehabilitation and requires complete reconstruction. Not proceeding with the design and the subsequent reconstruction will lead to increased and escalating maintenance costs and safety concerns.
