Subject: Request for Proposal 2021-54 Road Condition Assessment Report

Recommendation

That City Council approves the award of a contract to GM BluePlan Engineering Limited in the amount of \$94,856.27 (plus HST) to conduct a road condition assessment and update the pavement management system.

Background

The information gathered from road inspections is used in the City's Pavement Management System software to model and analyze the needs and determine the most cost-effective treatments to maintain, rehabilitate, or replace the pavement structure of the City's road network. Condition inspections were previously undertaken in 2007, 2011, and 2015. The project involves engineering services for the condition inspection of the City's asphalt roadway network. In accordance with the City's Asset Management Plan, the condition of the City's road network will be monitored and analyzed on an ongoing basis to determine and confirm prioritization with respect to the condition assessment and needs of the overall road and infrastructure network. In order to ensure the most cost-effective resurfacing program, regular updates of the road network condition data are required to ensure accurate and defendable needs assessments and work prioritization.

Financial/Legal Implications

A formal bid request, which closed June 21, 2021, was administered by the Purchasing Department and was publically advertised in accordance with the City's Purchasing By-Law 2013-200. Two proposals were evaluated by the Purchasing Manager, the Infrastructure Engineer, Senior Project Manager, Chief Draftsperson, and the Asset Management Manager. The evaluation considered experience, qualifications, project understanding and approach, methodology and work plan, schedule, and price.

The results are as follows:

The proposal from GM BluePlan Engineering Limited scored highest and provides the best overall value to the City. Their bid is considered fair and reasonable.
