## Recommendation

That Council authorizes an amendment to City of North Bay By-Law 2018-53, being a By-Law to Regulate the Administration of Building Permits, as amended, as set out in Report to Council CSBU 2021-057 by Beverley Hillier dated October 28, 2021.

### Background

Council adopted By-law 2018-53 on August 14, 2018. The *Building Code Act, 1992*, SO 1992, c 23 requires that Council appoint the Chief Building Official and various inspectors as necessary to regulate and enforce the provisions of the Act.

Carly Price has returned to the City from Parental Leave and the amendment to the Building Bylaw is required to re-appoint Mrs. Price as the Chief Building Official under the Building Code Act. As a result of Mrs. Price's return Aaron Lott will resume his position of Plan Examiner.

In addition, Andrew McGee is no longer employed with the City. The amendment to the By-law reflects this change.
