### Recommendation

That Council authorize an amendment to the Clean Yards By-Law 2022-28 as set out in Report to Council CORP 2022-074 dated June 10, 2022.

### Background

On March 22, 2022, Council passed the Clean Yards By-law No. 2022-28 and repealed the Clean Yards By-law No. 2011-185.

On May 17, 2022, Council approved the Part I Set Fine Schedule for By-Law 2022-28.

The Office of the City Solicitor submitted a Set Fine Application to the Ministry of the Attorney General for the approval of a Set Fine Schedule for By-Law 2022-28.

Upon further review and feedback, we feel the general penalty provision found in Section 5.6.1 of By-Law 2022-28 should be expanded.

Section 5.6.1 of By-Law 2022-28 currently reads as follows: "Every person who contravenes any provision of this By-Law is guilty of an offence."

Section 5.6.1 of By-Law 2022-28 should be amended to read as follows: "Every person who contravenes any provision of this By-Law is guilty of an offence and upon conviction is liable to a fine as provided for by the Provincial Offences Act, R.S.O. 1990, Chapter P.33, as amended."

## Financial/Legal Implications

An approved Set Fine Schedule for By-Law 2022-28 will allow for fines to be issued to an offender without the requirement for a Court appearance, which reduces costs and time for By-Law Enforcement and the Provincial Offences Office.
