#### Recommendation

That Council approve the award of a contract to New World Park Solutions Inc. in the amount of \$125,000.00 (plus HST) for the provision of play equipment at the Police Playground.

## Background

In the City's 2021 Parks Master Plan, Police Playground was classified as a Neighbourhood and Community Park. Based on this classification there should be a play structure installed at Police Playground in order to meet the needs of the surrounding neighbourhood. There is currently no play structure in this park.

## **Financial/Legal Implications**

A formal bid request, which closed July 4, 2022, was administered by the Purchasing Department and was publically advertised in accordance with the City's Purchasing By-Law 2013-200. Seven proposals were evaluated by the Purchasing Manager, Supervisor, Parks and Manager, Parks. The evaluation considered mandatory technical requirements related to the product's performance and features, experience, qualifications, play value, inclusive play, layout & circulation, durability, stringer and footing design and layout, work plan, schedule and price. The results are as follows:

The proposal from New World Park Solutions Inc. scored highest and provides the best overall value to the City. Their bid is considered fair and reasonable.

Sufficient funding for this purchase is available in Capital Project No. 6627PR – Parks and Playgrounds Rehab Program 2022 On-going.

# **Options Analysis**
