### Background

The City's Grant Facilitator applies for all grants through the Provincial government, Federal government, and any other grant opportunities available to the Municipality. The grant funder from time to time request a by-law that authorizes the signatory on the application.

As some grant applications require a quick turn-around time to be submitted, it is being recommended that the City of North Bay's Delegation By-Law be amended to delegate this duty to the Chief Administrative Officer.

It is also being recommended that the signing of subsequent submissions, declarations or representations for the receipt of funds be delegated to the Treasurer or the Deputy Treasurer in the Treasurer's absence.

### Financial/Legal Implications

Applications are typically submitted for projects identified in the City's Capital Budget. If an application is made for grant funding where the City contribution is required and is not in the budget, Council will be required to authorize the transfer of funds to the project upon approval of the application either through a separate report to Council or through the City's budget

process.
