Recommendation

That City Council approves the award of a contract to InfoTech Research Group, in the amount of \$216,000 (plus HST) for IT Research Subscription Services and Consulting, for a term of three (3) years.

Background

Part of the City of North Bay's Strategic Plan is to implement and utilize technology to achieve corporate goals service delivery. In keeping with this corporate objective, the vision for the Enterprise Resource Planning (ERP) project is to implement an integrated ERP system that supports staff in the delivery of municipal programs and services; takes advantage of best practices; and significantly improves the efficiency and effectiveness of the City's work processes.

The City of North Bay has used Naviline HTE (now SunGard Public Sector) for approximately twenty years. The applications include general ledger, cash, purchasing, billing (water/tax), building, work orders, code enforcement, human resources, payroll, accounts receivable, accounts payable, transit and licensing. Due to changing technologies, it is appropriate to re-evaluate the current system, evaluate other systems and determine if an alternative solution can provide enhancements in service delivery and if administrative efficiencies can be gained. After reviewing effective ways to implement new ERP systems, as well as gathering information from other municipalities, it was determined that using a consulting organization specializing in research, business process reviews, requirements gathering, ERP software packages and offerings, would assist The Corporation of the City of North Bay in streamlining and expediting the procurement of the software.

Financial/Legal Implications

This award is being made through the Ontario Vendor of Record (VOR) program that is available to the City. The Ontario VOR program advertises procurement processes, on behalf of their Ontario Public Service (OPS) Ministries and Non-OPS members and meets all legislative trade agreement requirements. Public notice of participation with this buying group, as required by the Canadian Free Trade Act CFTA (2017), is published on the City's website and Bids and Tenders.

As part of a second stage selection process, the City requested proposals from four suppliers awarded contracts through Tender 10941 Information Technology Research Subscription Services. This invitational bid request was administered by the Director Information Systems. Three (3) proposals were received and evaluated by the Purchasing Manager and the Director Information Systems. The proponents were evaluated on available services, Enterprise Resource Planning software consulting & analysis, and price.

The results are as follows:

The bid price of \$216,000.00 (plus HST) from InfoTech Research Group represents a total cost over the three (3) year term. The proposal from InfoTech Research Group scored highest and provides the best overall value to the City. Their bid is considered fair and reasonable.

Sufficient funding for this contract is available in Capital Project No. 3912GG/WS – Integrated Software Solution.

Options Analysis

- Option 1: That City Council approves the award of a contract to InfoTech Research Group, in the amount of \$216,000 (plus HST) for IT Research Subscription Services and Consulting, for a term of three (3) years.

This option is not recommended as InfoTech Research Group provides expert knowledge and toolkits on current Enterprise Resource Planning (ERP) software packages, business requirements gathering and process reviews, which will help expediate the process of procuring and installing a new ERP system for The Corporation of The City of North Bay.

Recommended Option

That City Council approves the award of a contract to InfoTech Research Group, in the amount of \$216,000 (plus HST) for IT Research Subscription Services and Consulting, for a term of three (3) years.
