### Recommendation

That City Council approves the award of a contract to Priestly Demolition Inc., based on the unit rates specified in their bid for RFQ 2023-09 for crushing and stockpiling reclaimed asphalt pavement and concrete, for a term of one year, with an option in favour of the City to extend the agreement for two (2) additional terms of up to one (1) year each.

---

### Background

Public Works accumulates and crushes reclaimed asphalt and concrete from various construction and repair projects. The accumulated material is recycled and processed to be used as aggregate for inhouse maintenance and capital projects. The material processing work is outsourced to a contractor with specialized equipment. Approximately 20,000 tonnes of reclaimed asphalt and 5,000 tonnes of concrete are recycled annually.

### Financial/Legal Implications

A formal bid request, which closed February 9, 2023, was administered by the Purchasing Department and was publically advertised in accordance with the City's Purchasing By-Law 2013-200. Six quotes were evaluated by the Purchasing Manager and the Manager of Roads, Traffic and Landfill Operations. The evaluation considered company ability, experience, equipment, and price.

The results are as follows:

The bid price of \$134,450.00 (plus HST) from Priestly Demolition Inc. represents a total cost over the initial one (1) year term based on the estimated quantities specified in the RFQ. Under the terms of the contract, the City will pay the unit rate specified for each item bid and is not bound to any specific quantities. The quote from Priestly Demolition Inc. was the lowest bid and provides the best overall value to the City. Their bid is considered fair and reasonable.

The actual quantity and value of the work requested will vary based on operational requirements and budget availability. Funding for crushing of reclaimed asphalt pavement and concrete services provided under this contract is managed within the operating and capital budgets of various departments. Funding for 2023 and future years will be requested during the budget process. Operational departments will ensure that the quantity and value of work requested does not exceed the funding allocated in the following:

- 2023 Infrastructure and Operations Operating Budget;
- 2023 Water and Wastewater Operating Budget; and
- Any associated capital projects.

### Options Analysis

---

Option 1: That City Council approves the award of a contract to Priestly Demolition Inc., based on the unit rates specified in their bid for RFQ 2023-09 for crushing and stockpiling reclaimed asphalt pavement and concrete, for a term of one year, with an option in favour of the City to extend the agreement for two (2) additional terms of up to one (1) year each. This option is recommended because it is environmentally friendly, economically viable and provides significant savings to the corporation when compared to purchasing comparable aggregate material.

Option 2: Do not award a contract. This option is not recommended because the corporation will incur unnecessary costs of purchasing comparable aggregate material.

### **Recommended Option**

That City Council approves the award of a contract to Priestly Demolition Inc., based on the unit rates specified in their bid for RFQ 2023-09 for crushing and stockpiling reclaimed asphalt pavement and concrete, for a term of one year, with an option in favour of the City to extend the agreement for two (2) additional terms of up to one (1) year each.
