Recommendation

That City Council approves the award of a contract to Miller Paving Limited in the amount of \$320,152.50 (plus HST) for rural road surface treatment on Feronia Road, Northmount Road and Smith Road.

Background

The City of North Bay maintains roughly 158 lane km of rural surface treated roads. Surface treatment is a combination of asphalt emulsion and clear aggregate which is spread on the road surface then rolled in place. Surface treatment is commonly used in rural areas due to the fact it is more cost effective than traditional hot mix. The life cycle of surface treated roads depends on numerous factors such as traffic volume, drainage and vehicle type but typically last for 8 to 12 years. The sections on Northmount Road, Smith Road and Feronia Road have not been surface treated since the early 2000's.

Financial/Legal Implications

A formal bid request, which closed June 5, 2023, was administered by the Purchasing Department and was publically advertised in accordance with the City's Purchasing By-Law 2013-200. Two quotes were evaluated by the Purchasing Manager and the Manager of Roads, Traffic and Landfill Operations. The evaluation considered company ability, experience and price.

The results are as follows:

Ranking	Company	Bid Price
1	Miller Paving Limited	\$320,152.50
2	Duncor Enterprises Inc.	\$419,491.80

The quote from Miller Paving Limited was the lowest bid and provides the best overall value to the City. Their bid is considered fair and reasonable.

Sufficient funding for this contract is available in Capital Project No. 6698RD – Rural Road Rehab 2023 On-going.
