Subject: 2022 Treasurer's Statement on Development Charges

Recommendation

That Council receive the 2022 Treasurer's Statement on Development Charges, for information purposes, as attached to Report to Council CORP 2023-056 dated June 23, 2023 from Shannon Saucier and that a copy be submitted to the Minister of Municipal Affairs and Housing upon request.

Background

Section 43 (1) of the Development Charges Act, 1997, S.O. 1997, c. 27, (the Act), states that the treasurer of a municipality shall each year on or before such date as the council of the municipality may direct, give the council a financial statement relating to development charge by-laws and reserve funds established under section 33.

Section 43 (2) of the Act requires the statement to include the opening and closing balances of the reserve funds and the transactions relating to the funds; all assets whose capital costs were funded under a development charge by-law during the year and the manner in which any capital cost not funded under the by-law was or will be funded; and a statement as to the compliance with subsection 59.1 (1) of the Act. The Treasurer's Statement is to be made available to the public.

Section 43 (3) of the Act stipulates that the Treasurer shall provide a copy of the statement to the Minister of Municipal Affairs and Housing on request.

Specific Objectives

Options Analysis

Development Charges (DCs) are fees collected by municipalities to assist in financing the growth-related capital costs of providing services such as roads, water and wastewater services, police, fire and transit. Development Charges are determined in accordance with the City's Development Charges By-Law No. 2019-72 as amended (formerly By-law 2014-128) and fees collected are deposited into the appropriate reserve funds based on service category.

The following summarizes the combined activity that occurred in the Development Charges reserve funds during the 2022 fiscal year:

Development Charges collected are allocated to growth related capital projects as part of the City's capital budgeting process. A total of \$1,874,245.00 of the Development Charges reserve balance has been earmarked to finance growth related capital projects in the 2023 Capital Budget and Capital Forecast for 2024 to 2032. These projects were identified based on the July 25, 2019 Background Study completed by Hemson Consulting Ltd. There is also an additional \$1,146,196.73 in Development Charges earmarked for pre-2023 capital projects and \$30,000.00 for future DC Background Studies.

Development Charges remain in the reserve funds until eligible expenditures have been incurred at which time the funds are transferred from the reserve funds to the growth related capital projects.

Section 59.1 (1) of the Act stipulates that “a Municipality shall not impose, directly or indirectly, a charge related to a development or a requirement to construct a service related to development, except as permitted by this Act or another Act.” The City was compliant with this requirement during the reporting period.

In accordance with Section 43 of the Act, Schedule A provides a summary of the financial activity in the Development Charge reserve funds by service category for the year ended December 31, 2022. Schedule B provides a detailed breakdown of the sources of funding for each capital project that was funded in part by Development Charges in 2022.

Recommended Option
