#### Recommendation

That Council authorize the City Clerk to amend City of North Bay By-Law 2023-02, being a By-Law to Authorize User Fees for City Departments, as set out in Report to Council CSBU 2024-020 dated April 25, 2024.

#### **Background**

Council passed General Government Committee Report No. 2024-88 on April 2, 2024. Item (6) in that Committee Report requires that a Public Meeting be held regarding the proposed user fees for the use of Pickleball Courts and proposed changes to Transit Fares.

### **Pickleball Courts**

A user fee review has been completed for the pickleball courts in Bourke Park. It is recommended that a rental fee be applied for all organized league or community play. A fee of \$16.00/ for a 3 hour block (\$4 operating and \$12 CRF) for two courts is recommended.

#### **Transit Fares**

The last Transit fare increase occurred in 2015. Since 2015, transit has experienced increases in vehicle operating costs, fuel costs and material costs. A user fee review has been completed and current cash fares fall below provincial averages for 2022.

Proposed is an increase in transit fares and pass fees:

| Multiple Fare Cards (10-trip) | \$27.00             | \$29.25          |

| Student Monthly               | \$71.00             | \$77.00          |
| Reduced Monthly               | \$61.00             | \$66.00          |
| Day Pass                      | \$8.00              | \$9.00           |
| Single Trip Card              | \$3.00              | \$3.25           |

In order to enact the user fees associated with the Service Level Changes approved in the 2024 Operating Budget, an amendment to Schedules "F" and "M" of City of North Bay By-Law No. 2023-02, being a By-Law to Authorize User Fees for City Departments is required.

### Financial/Legal Implications

#### **Pickleball Courts**

Estimated annual revenue for pickleball courts resulting from the new fees is approximately \$8,600 (including both the operating and CRF component of the fee).

### **Transit Fares**

Estimated revenue increases for transit are based on 2024 projections. Proposed implementation date of July 1, 2024.
