## By-Law No. 2024-62

## Being a By-Law to Assume and Establish Part of a Public Highway (Sugarbush Street, Pearce Street & Katie Ann Crescent) And to Amend By-Law 2002-133

**Whereas** Section 31(2) of the *Municipal Act, 2001*, S.O. 2001, as amended, authorizes a Municipality to pass a By-Law to establish a highway.

**And Whereas** By-Law No. 2021-38 passed on the 6th day of April, 2021, Council authorized a Subdivision Agreement for 1804016 Ontario Inc. for 12 Lots and 5 Blocks on Sugarbush Street, Katie Ann Crescent and Pearce Street dated April 21, 2021.

**And Whereas** By-Law No. 2024-45 passed on the 21<sup>st</sup> day of May, 2024, Council authorized a Subdivision Agreement for 1804016 Ontario Inc. for 28 Lots and 5 Blocks on Katie Ann Crescent dated May 21, 2024.

**And Whereas** it is deemed expedient to assume the One Foot Reserve, Block 14, PLAN 36M-709 as part of the roadway.

## Now, therefore, the Council of The Corporation of the City of North Bay hereby enacts as follows:

- 1. That Block 14, Plan 36M-709 being part of Katie Ann Crescent in the City of North Bay, District of Nipissing, is hereby assumed and established as part of a Public Highway (PIN 49134-0565).
- 2. That Katie Ann Crescent, Plan 36M-709 as in PIN 49134-0569 is hereby assumed and established as part of a Public Highway.
- 3. That Sugarbush Street, Plan 36M-709 as in PIN 49134-0570 is hereby assumed and established as part of a Public Highway.
- 4. That Pearce Street, Plan 36M-709 as in PIN 49134-0571 is hereby assumed and established as part of a Public Highway.
- 5. That Katie Ann Crescent, Plan 36M-723 as in PIN 49134-0620 is hereby assumed and established as part of a Public Highway
- 6. By-Law 2002-133 is hereby amended by adding the attached Schedule "K".
- 7. This by-law shall come into effect as of and from September 3, 2024.
