By-Law No. 2024-69

Being a By-Law to Amend By-Law 2019-72 to Establish Development Charges for The Corporation of the City of North Bay

Whereas the City of North Bay enacted By-Law 2019-72 (the "By-Law") pursuant to the *Development Charges Act, 1997*, S.O. 1997, c. 27 (the "Act"), which Act authorizes Council to pass By-Laws for the imposition of development charges against land;

And Whereas the By-Law was amended by By-Law 2022-36 being a By-Law to Amend By-Law 2019-72 to Establish Development Charges for The Corporation of the City of North Bay;

And Whereas Section 9 (1) of the Act, as amended, provides that unless it expires or is repealed earlier, a development charge By-Law expires 10 years after the day it comes into force;

And Whereas Council passed Resolution No. 2024-231 at its Regular Meeting of Council held on August 13, 2024 by which Council authorized an amendment to the By-Law, as amended by By-Law 2022-36, to reflect an expiry date of October 10, 2029, unless it is extended by statute, regulation or By-Law, or repealed at an earlier date;

Now Therefore the Council of The Corporation of the City of North Bay Enacts As Follows:

- 1. That Schedule "B1" to By-Law 2019-72, Schedule of City-Wide Discounted DC Rates, as amended, is hereby deleted and the attached schedule "B1" be inserted in lieu thereof.
- 2. That Schedule "B2" to By-Law 2019-72, Schedule of City-Wide Non-Discounted DC Rates, as amended, is hereby deleted and the attached schedule "B2" be inserted in lieu thereof:
- 3. The By-Law, as amended, shall expire on October 10, 2029, unless it is extended by statue, regulation or By-Law, or repealed at an earlier date.
- 4. (1) By-Law 2024-69 shall come into full force and effect on October 2, 2024.
 - (2) By-Law 2024-69 shall continue in force and effect for a term expiring on the date of expiry of By-Law 2019-72, as amended, being October 10, 2029, unless it is extended by statute, regulation or By-Law, or repealed at an earlier date.
