### Recommendation

That Council accept the recommendation of the Community and Recreation Centre Ad Hoc Committee and direct staff to prepare and issue a Request for Expression of Interest for the construction of a new Community and Recreation Centre to be located adjacent to the Omischl Sports Complex with an upset limit of \$52 million dollars that will include the minimal functional programming attached as Appendix A to Report to Council CAO-2023-001 dated September 8, 2023 from John Severino.

### Background

In response to Council Resolution 2023-327, Council created a Community and Recreation Centre Ad hoc Committee. Terms of Reference of the Ad hoc Committee were adopted as outlined in Report to Council IO 2023-017.

The Ad hoc Committee met two (2) times. The Ad hoc Committee recommends to Council to proceed by way of an Expression of Interest at the present location with an upset limit of \$52 million dollars that will include the minimal functional programming.

The project location is adjacent to the Omischl Sports Complex on Lakeshore Drive. The upset limit is for the total project costs beginning September 01, 2023. The upset limit excludes any street or intersection improvements which will be funded through Project No. 4025RD Booth Road and Lakeshore Drive Intersection Reconstruction.

The project must be designed to meet the requirements of the Canadian Green Building Council (CaGBC) Zero Carbon Building (ZCB) – Design Standard (version 2).
